SHOW CAUSE NOTICE

Whereas Jharkhand Teachers' Training College, Jhumri Telaiya, Koderma, Plot No.- 3515, Vill.- Tealiya basti, PO./Town/City- Jhumri Tealiya, Koderma, Dist. - Koderma, Jharkhand - 825409 (ERCAPP1296) has been granted recognition for conducting B.Ed. Course vide order dated 08.07.2013 with an intake of 100 (two basic units) from the academic session 2014-2015.

2. AND WHEREAS, on the basis of implementation of NCTE Regulations 2014, Revised Recognition Order was issued on or before 31st May, 2015 from the academic session 2015-2016 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update institutional website and to comply the same to the ERC.

3. AND WHEREAS, the ERC in its 263rd meeting held on 15th - 16th November, 2018 after considering and examining the application along with the documents submitted by the institution, agenda note, NCTE Act, NCTE Regulations 2014 including Norms and Standards, guidelines received from NCTE Hqrs. from time to time and compliance report received in response to revised recognition order, the Committee discussed the matter in detail and observed as under:

- (i) Faculty list duly approved by the concerned affiliating body is not submitted.
- (ii) Building plan and building completion certificate duly approved by Govt. Engineer are not submitted.
- (iii) Validity of FDRs of Rs.5 lakh and Rs.3 lakh expired on 07.05.2018 and also another FDR of Rs.4 lakh is not in joint operation mode. The institution is required to submit FDRs of Rs.5 lakh and Rs.7 lakh towards L.F. & R.F. in joint operation mode as per NCTE Regulations, 2014.
- (iv) Website not maintained and updated.

In view the above, the Committee decided as under:

Show Cause Notice be issued to the institution as to why the recognition granted be not withdrawn on the above points. The Committee therefore, provides last opportunity under section 17(1) of the NCTE Act 1993 to the institution to submit its reply within 21 days from the issue of this letter before the Committee takes final decision.


4. And whereas the Committee is of the opinion that the institution prima facie, does not fulfill the requirements, the norms and standards laid down by the NCTE in accordance with the provisions of the NCTE Act, 1993, as detailed above.

5. Now therefore, as per the Section 17(1) of NCTE Act, 1993, before the Regional Committee passes the final order on your application, you are hereby given an opportunity for making such written representation within the stipulated time as mentioned on this notice along with the supporting documents.
